The following WTO airgram WTO/AIR/3815/REV.1 contains the agenda for the upcoming WTO Council for TRIPS meeting to be held in Geneva from Monday, 24 October 2011 to Tuesday, 25 October 2011. Paragraph 3 and agenda items G, N and O will be of interest to readers of this blog. It should be noted that in the original document, the text is capitalized. Item G covers Review under Paragraph 8 of the Decision on the implementation of Paragraph 6 of the Doha Declaration on the TRIPS Agreement and Public Health. Ukraine requested that the TRIPS Council discuss Australia's Tobacco Plain Packaging Bill 2011 under agenda item N. Australia, Canada, EU, Korea, Japan, New Zealand, Singapore, Switzerland and the US have made a written request to the WTOto discuss 'enforcement of intellectual property rights (Part III of the TRIPS Agreement)' under agenda item O.
